Post-Conviction Litigation Help

The organizations listed below¹ provide free legal help to innocent people in prison. To find help, look at the "National Organizations" section and the section for the state where the conviction happened.

Most listed organizations only take "actual innocence" cases. Actual innocence means you did not commit the crime. If you committed the crime but want to fight your sentence for other reasons (like a clearly unfair trial or sentence), your case does not count as actual innocence.

Please read the rules for each organization carefully. Generally, you must have finished all direct appeals before applying. To ask for help, email or call the organization for an intake questionnaire or mail a letter explaining your case to the address provided. Most state-specific organizations will only accept federal cases if you were convicted in that state.
